

**The overall objective** of WetMainAreas project is protection, conservation and development of wetlands as shared asset of the Balkan-Mediterranean territory (Bulgaria, Greece, Albania, North Macedonia and Cyprus).

## The project's main specific objectives are:

- To assess Balkan-Mediterranean wetland connectivity beyond the boundaries of protected areas and national borders, in order to improve knowledge on ecological connectivity and transnational ecosystems' integration in the Balkan-Mediterranean territory.
- To support policy and action plans by integrating scientific knowledge into guidance documents, available to everybody and thus improve the capacity of authorities, spatial planners, and developers to take informed decisions and to cooperate towards ecosystem integration and sustainability.

The project territory covers 3 568 225 ha, including Bulgaria, Greece, Albania, North Macedonia and Cyprus.



The project identified 4 pilot demonstration sites, that will represent good practices for management and conservation of wetlands in the context of European Directives.

## **Project methodology:**

• Mapping and satellite-based monitoring (through satellite Sentinel-2) of wetlands within the project territory (during project implementation 5376 wetlands were mapped in Bulgaria)

- Creation of database
- Assessment on ecological connectivity of wetlands within the project territory. The assessment is based on connectivity indicators connected with assessment on wetlands' ecosystem potential to provide ecosystem services.
- Detailed research on the pilot sites, completing the database, raising proposals for improving the conservation effectiveness of wetlands in the pilot sites.
  - Assessment on cultural heritage within the pilot sites.
  - Development of Guideline with conservation techniques for wetlands.
  - Assessment on wetlands relevant policies within the project territory.
- Recommendations to the wetlands conservation policies within the project territory.
- Publications about the wetlands in national and regional relevant policies, addressing key stakeholders.
- Living Lab with participation of key stakeholders and policy makers aiming at discussion on project results and opportunities for improving the wetlands policies.

#### **Project results:**

- Database and maps of wetlands ecosystems in the Balkan-Mediterranean territory, available through Geoportal.
- Identified indicators for ecological and spatial connectivity of wetlands in and outside protected areas and protected sites;
- Guideline and pilot assessments on ecological connectivity of wetlands ecosystems within the pilot sites.
  - Guideline and pilot assessment on cultural heritage within the pilot sites.
  - Assessment on wetlands conservation policies.
  - Integration of project results into wetlands policy.
  - Interactive map of wetlands within the project territory.
